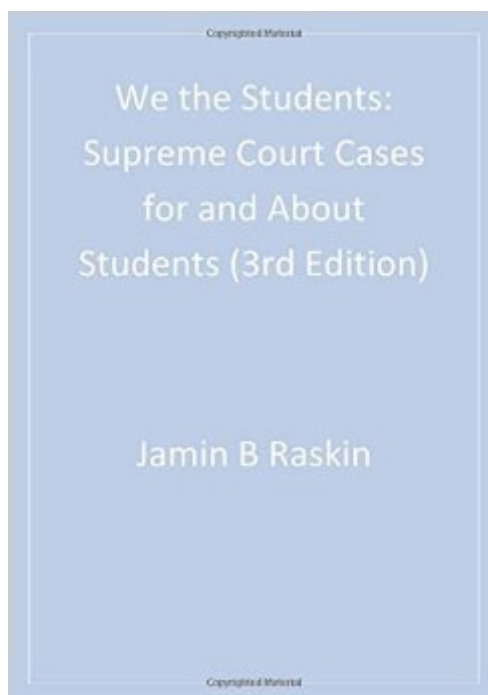

Jamie Raskin has presented a variety of topics with relevant court cases and commentary, and suggestions for leading classroom discussions or homework. I had the 2d edition; now find the third is even better.

This book offers young people an in-depth look at Supreme Court cases that are relevant to them. Raskin's method of sharing these cases is done in a manner that is very engaging to students.
